4 ✓ 2. Page ⁴⁵~~38~~, line ²⁰~~8~~: after that line insert:

5 "^{ag}~~(a)~~ Notwithstanding par. (a) 3m., the authorized representative of a group
6 home or a residential care center for children and youth may permit a licensee or
7 out-of-state licensee to carry a concealed weapon in the home or center if the
8 authorized representative gives written notice to the parents or guardians of the
9 individuals placed in the home or center and to the court that placed the individuals
10 in the home or center."
