3 "17. A building or structure owned by the state or a local unit of government,
4 as defined in s. 16.53 (11), except that the prohibition under this subdivision shall
5 not apply to any such local unit of government whose governing body, by a two-thirds
6 majority vote, passes a resolution expressly permitting a licensee or an out-of-state
7 licensee to carry a concealed weapon in a building or structure owned by the local unit
8 of government."
