Page 45 line 23 after that line insert (ap) Neither a licensee nor an out-of-state licensee may carry a concealed weapon while he or she is in or on a motor vehicle, including a snowmobile or an all-terrain vehicle.

- 1 At the locations indicated, amend the bill as follows:
 - 2 1. Page 12, line 5: delete ", (b), and (c)".
 - 3 2. Page 43, line 21: delete that line and substitute:
 - 4 "(15m) PRIVATE EMPLOYER RESTRICTIONS. A."
 - 5 3. Page 44, line 1: delete lines 1 to 4.
