

1 At the locations indicated, amend the bill as follows:

2 1. Page 12, line 3: after that line insert:

3 "SECTION 14g. 165.85 (4s) of the statutes is created to read:

4 165.85 (4s) TRAINING FOR APPLICANTS FOR A LICENSE TO CARRY A CONCEALED  
5 WEAPON. The board shall establish training standards that a firearm training or  
6 firearm safety course or class under s. 175.50 must meet for applicants for a license  
7 to carry a concealed weapon."

8 2. Page 29, line 5: after "to 5." insert "shall meet the training standards  
9 established by the law enforcement standards board under s. 165.85 (4s) and".
