Mike -

I believe this is our last amendment request to SB 214. Under the provisions of Engrossed SB 214, it appears that the penalty for "false swearing" when applying for a concealed carry license is reduced to a *misdemeanor* (fined not less than \$500 nor more than \$10,000 and may be imprisoned for not more than nine months).

Current state law for false swearing under oath when the swearing is a prerequisite for a public officer or governmental agency taking some official action is a *Class H felony* [s. 946.32(1)(a)].

***Rep. Cullen would like to amend Engrossed SB 214 to reflect that false swearing when applying for a license is a Class H felony.***
