1 At the locations indicated, amend the engrossed bill as follows:

2 **1.** Page 28, line 21: after that line insert:

3 "(qm) Within the preceding 3 years, the individual was not convicted of, or was
4 not serving a sentence or on probation for, a violation of sub. (2k) (e) or (16) (cm) 1."

5 **2.** Page 32, line 2: after "(o)," insert "(qm),".

6 **3.** Page 32, line 21: after "(o)," insert "(qm),".

7 **4.** Page 32, line 24: after "(o)," insert "(qm),".

8 **5.** Page 33, line 3: after "(o)," insert "(qm),".

9 **6.** Page 34, line 9: after "(o)," insert "(qm),".

10 **7.** Page 34, line 14: after "(o)," insert "(qm),".

11 **8.** Page 35, line 13: after "(o)," insert "(qm),".

1 **9.** Page 47, line 14: after “or both” insert “or a violation of subd. 1. a. or s. 941.20
2 (1) (bm) or both”.

3 **10.** Page 47, line 16: before “, the” insert “or both subd. 1. a. and s. 941.20 (1)
4 (bm)”.

5 **11.** Page 47, line 17: after “require.” insert “Subdivision 1. a. and s. 941.20 (1)
6 (bm) each requires proof of a fact for conviction which the other does not require.”.

7 **12.** Page 47, line 18: delete “This subsection does” and substitute “Paragraphs
8 (a), (at), (b), and (c) do”.

9 **13.** Page 47, line 21: delete “(2k) (e) or (16)” and substitute “(16) (a), (at), (b),
10 or (c)”.

11 **14.** Page 47, line 22: after that line insert:
12 “(bm) Any person who violates sub. (2k) (e) or (16) (cm) may be fined not more
13 than \$10,000 or may be imprisoned for not more than 9 months or both.”.

14 **15.** Page 53, line 11: after “a. or b.” insert “or s. 941.20 (1) (bm)”.

15 **16.** Page 55, line 3: delete lines 3 to 7 and substitute “influence of an
16 intoxicant.”.
