TO 2003 ASSEMBLY BILL 493 237

1 At the locations indicated, amend the bill as follows:

2 ✓ 1. Page 2, line 1: delete lines 1 and 2 and substitute:

3 "SECTION 1. 59.69 (2) (bm) of the statutes is amended to read:"

4 ✓ 2. Page 2, line 3: delete "(intro.)".

5 ✓ 3. Page 2, line 11: delete that line and substitute "not condition or withhold
6 approval of a conditional use permit under this section based upon the property
7 owner entering into a contract, or discontinuing, modifying, extending, or renewing
8 any existing contract, with a 3rd party under which the 3rd party is engaging in a
9 lawful use of the property."

10 ✓ 4. Page 2, line 12: delete lines 12 to 20.

11 5. Page 2, line 21: before that line insert:

12 "SECTION 3m. 60.61 (4) (e) of the statutes is created to read:
