12 to approve or disapprove the application within 14 days after receiving the
13 application".

1 **5.** Page 16, line 11: after “approval” insert “, unless the department intends
2 to approve or disapprove the application within 14 days after receiving the
3 application”.

4 **6.** Page 19, line 9: after “application” insert “, unless the department intends
5 to approve or disapprove the license or building plan application within 14 days after
6 receiving the license or building plan application”.

7 **7.** Page 21, line 6: after “application” insert “, unless the department intends
8 to approve or disapprove the application within 14 days after receiving the
9 application”.

3 **"SECTION 28m. Nonstatutory provisions.**

4 (1) SUBMISSION OF RULES. The state agencies required to promulgate rules under
5 this act shall submit in proposed form the rules required under this act to the
6 legislative council staff under section 227.15 (1) of the statutes no later than the first
7 day of the 7th month beginning after the effective date of this subsection."

8 ~~2.~~ Page 37, line 17: delete lines 17 to 19 and substitute:

9 **"SECTION 30b. Effective dates.** This act takes effect on the first day of the
10 12th month beginning after publication, except as follows:

11 (1) SECTION 28m of this act takes effect on the day after publication."
