2 **1.** Page 1, line 4: after "center," insert "the construction of a facility for an
3 organization known as the Multicultural Center of Greater Green Bay,".

4 **2.** Page 2, line 14: delete "\$3,000,000" and substitute "\$2,500,000".

5 **3.** Page 2, line 24: after that line insert:

6 "SECTION 1m. 13.48 (38) of the statutes is created to read:

7 13.48 (38) MULTICULTURAL CENTER OF GREATER GREEN BAY. (a) The legislature
8 finds and determines that the population of Wisconsin consists of a number of
9 peoples of diverse cultures. The legislature finds that supporting cultural diversity
10 throughout Wisconsin is a statewide responsibility of statewide dimension. To better
11 ensure the cultural diversity of this state, the legislature finds that it will have a
12 direct and immediate effect on a matter of statewide concern for the state to construct

1 a facility for an organization known as the Multicultural Center of Greater Green
2 Bay.

3 (b) Notwithstanding s. 18.04 (1) and (2), the building commission shall
4 authorize \$500,000 in general fund supported borrowing to make a grant to an
5 organization known as the Multicultural Center of Greater Green Bay for
6 construction of a facility in Green Bay. As a condition precedent to receipt of the
7 grant, the organization shall enter into an agreement with the secretary of
8 administration guaranteeing that the facility will be operated to serve the
9 nonsectarian cultural interests.

10 (c) If, for any reason, the grant under par. (b) is not used to construct the facility
11 in Green Bay, or the center is not operated to serve nonsectarian cultural interests,
12 the state shall retain an ownership interest in the facility equal to the amount of the
13 state's grant."

18 20.866 (2) (zbt) *Multicultural Center of Greater Green Bay*. From the capital
19 improvement fund, a sum sufficient for the building commission to provide a grant
20 to the organization specified in s. 13.48 (38) (b) for construction of a facility in the city
21 of Green Bay. The state may contract public debt in an amount not to exceed
22 \$~~500,000~~^{2,000,000} for this purpose. *De*
