1 **AN ACT ...; relating to:** prohibiting a county from providing a grant to a nonprofit
2 corporation from community aids unless the nonprofit corporation provides
3 matching funds.

Analysis by the Legislative Reference Bureau

Under current law, the Department of Health and Family Services (DHFS) distributes general purpose revenues and federal revenues, as community aids, to counties to provide social, mental health, developmental disabilities, and alcohol and other drug abuse services. This bill prohibits a county from providing a grant to a nonprofit corporation, from community aids, unless the nonprofit corporation provides matching funds equal to 100% of the grant moneys awarded. The match may be in the form of money or in-kind services, or both, but may not include any moneys received from the federal, state, or county government. If in any year the amount of grants provided by a county to nonprofit corporations, from community aids, exceeds the amount of matching funds provided by those corporations for those grants in that year, DHFS must decrease the amount of community aids distributed to that county in the next year by the difference between the amount of grants provided and the amount of matching funds provided.

For further information see the ***state and local*** fiscal estimate, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

4 **SECTION 1.** 46.495 (1) (g) of the statutes is created to read:

1 46.495 (1) (g) A county department under s. 46.215, 46.22, or 46.23 may not
2 provide a grant to a nonprofit corporation, as defined in s. 46.93 (1m) (c), from moneys
3 distributed under par. (d), unless the nonprofit corporation provides matching funds
4 equal to 100% of the grant moneys awarded. The match may be in the form of money
5 or in-kind services, or both, but any moneys used by a nonprofit corporation toward
6 a match may not include moneys received from the federal, state, or county
7 government. If in any year the amount of grants provided by a county department
8 under s. 46.215, 46.22, or 46.23 to nonprofit corporations, from moneys distributed
9 under par. (d), exceeds the amount of matching funds provided for those grants in
10 that year, the department shall decrease the amount of moneys distributed to that
11 county department under par. (d) in the next year by the difference between the
12 amount of grants provided and the amount of matching funds provided.

13 **SECTION 2.** 51.423 (6m) of the statutes is created to read:

14 51.423 (6m) A county department under s. 46.23, 51.42, or 51.437 may not
15 provide a grant to a nonprofit corporation, as defined in s. 46.93 (1m) (c), from moneys
16 distributed under sub. (2), unless the nonprofit corporation provides matching funds
17 equal to 100% of the grant moneys awarded. The match may be in the form of money
18 or in-kind services, or both, but any moneys used by a nonprofit corporation toward
19 a match may not include moneys received from the federal, state, or county
20 government. If in any year the amount of grants provided by a county department
21 under s. 46.23, 51.42, or 51.437 to nonprofit corporations, from moneys distributed
22 under sub. (2), exceeds the amount of matching funds provided for those grants in
23 that year, the department shall decrease the amount of moneys distributed to that
24 county department under sub. (2) in the next year by the difference between the
25 amount of grants provided and the amount of matching funds provided.

Subject: Technical Correction to SB 262 (LRB-3025/1)

SB 262 references s. 46.93 (1m) (c) to define a nonprofit corporation. However Wisconsin Act 33 eliminated s. 46.93. A technical amendment will need to be drafted to define "nonprofit corporation" by cross-referencing another definition of that term, e.g., 46.035 (1) (c) or 46.99 (1) (a).
