**RE: Drafting Instructions: Repealing the University of Wisconsin System Exemption from Open Meetings Law**

On behalf of Senator Reynolds, I am requesting that a bill be drafted in good form that does all of the following:

1. Makes the University of Wisconsin System and its subunits subject to the same open meetings requirements as other units of government.
2. Repeals any exemption made for the University of Wisconsin System from open meetings requirements.
3. Would impose the same consequences for failure to follow the open meetings laws as other units of government.

It is the Senator's intent to subject the University of Wisconsin System and its subunits to the same open meeting requirements and consequences as any other unit of government. The only exceptions to meeting and serving notice of a meeting would be exemptions already granted to other units of government.

I will be the primary policy advisor on this legislation. Please treat this request confidentially until directed otherwise. If you have any questions, please feel free to contact me. Thank you in advance for your services.

Currently, state governmental bodies must give advance notice of their meetings to the public, to news media that have filed <sup>Δ</sup>written requests to be notified, and to the official state newspaper. The notice must include the date, time, place, and proposed subject matter of the meeting. <sup>Δ</sup>Notice must be given at least 24 hours prior to each meeting unless for good cause such notice is impossible or impractical, in which case shorter notice may be given, but in no case may less than <sup>Δ</sup>2 hours' notice be provided. Departmental committees, subcommittees, and similar bodies within the University of Wisconsin system are exempt from these requirements, but must provide notice of meetings which is reasonably likely to apprise interested persons and news media that have filed written requests for such notice.

This bill eliminates the exemption from notice requirements for departmental committees, subcommittees, or similar bodies within the University of Wisconsin system.
