1 At the locations indicated, amend the bill as follows:

2 1. Page 1, line 4: delete lines 4 to 6 and substitute:

3 "808.07 (2m) LIMIT ON UNDERTAKING. (a) During the pendency of an appeal of
4 a judgment in any civil action, the court shall set the amount of the undertaking to
5 be furnished by all appellants collectively in order to stay the execution of the
6 judgment during appellate review, but the undertaking shall not exceed
7 \$100,000,000."
