4 ✓ 3. Page 2, line 3: after that line insert:

5 "a) "Child support worker" means an employee of a county child support
6 agency under s. 59.53 (5), including the attorney responsible for child support
7 enforcement under s. 59.53 (6) (a).".

8 ✓ 4. Page 2, line 4: delete "(a)" and substitute "(am)".

9 ✓ 5. Page 3, line 1: after "intake worker," insert "a child support worker,".

10 ✓ 6. Page 3, line 5: after "worker," insert "a child support worker,".

11 ✓ 7. Page 3, line 7: after "intake worker," insert "the child support worker,".
