1 At the locations indicated, amend the substitute amendment as follows:

- 2 1. Page 5, line 18: after "1." insert "If the board has determined under sub. (1)
- 3 (b) to adopt staggered terms for the office of supervisor, the board may change the
- 4 expiration date of the term of any supervisor to an earlier date than the date provided
- 5 under current ordinance if required to implement the redistricting or to maintain
- 6 classes of members."
