

Under current law, no member of a state or local governmental body may be excluded from a meeting of a subunit of that body unless the rules of the body provide to the contrary.

This bill provides that no member of a state or local governmental body may be excluded from a meeting of a subunit of that body.

---

**SECTION 1.** 19.89 of the statutes is amended to read:

**19.89 Exclusion of members.** No duly elected or appointed member of a governmental body may be excluded from any meeting of such body. ~~Unless the rules of a governmental body provide to the contrary, no~~ No member of the body may be excluded from any meeting of a subunit of that governmental body.
