1 **AN ACT to create** 38.39 of the statutes; **relating to:** technical college district
2 contracts with businesses for the purpose of providing services and facilities.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 **SECTION 1.** ~~38.39~~ of the statutes is created to read:

4 **38.39 Wisconsin Advantage Jobs Training Program.** With the approval
5 of the board, a district board may on its own or jointly with any other entity contract
6 with a business located in the district to provide the business with one or more of the
7 following:

8 **(a)** (1) Training for jobs created or retained by the business.

9 **(b)** (2) Adult basic education.

10 **(c)** (3) Vocational and skill-assessment services.

11 **(d)** (4) Training facilities, equipment, and material.
