**SENATE AMENDMENT ,
TO 2003 SENATE BILL 404**

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 17, line 21: delete "or".

3 **2.** Page 17, line 23: before that line insert:

4 **"(2g)** This subchapter applies to a transaction governed by the federal
5 Electronic Signatures in Global and National Commerce Act, 15 USC 7001, et seq.,
6 but this subchapter is not intended to limit, modify, or supersede 15 USC 7001 (c).

7 **(2r)** To the extent that it is excluded from the scope of 15 USC 7003, this
8 subchapter does not apply to a notice to the extent that it is governed by a law
9 requiring the furnishing of any notice of:

10 (a) The cancellation or termination of utility services, including water, heat,
11 and power service.
