1 AN ACT ...; relating to: fees for certain motor vehicle registration plates.

a
Analysis by the Legislative Reference Bureau

Under current law, the Department of Transportation offers a special registration plate for person interested in obtaining a plate that displays the name of a University of Wisconsin campus. In addition to the regular registration fee, a person who obtains a University of Wisconsin plate pays a \$20 fee for issuance or reissuance of the plate. *X*

This bill increases the fee for a special plate *that* displays the name of a University of Wisconsin campus from \$20 to \$25. As under current law, the additional fee helps fund a scholarship program and may be claimed as a tax-deductible charitable contribution. *X*

For further information see the *state* fiscal estimate, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

2 SECTION 1. 341.14 [✓](6r) (b) 4. of the statutes is amended to read:
3 341.14 (6r) (b) 4. An additional fee of ~~\$20~~ \$25 that is in addition to the fee under
4 subd. 2. shall be charged for the issuance or renewal of a plate issued on an annual
5 basis for a special group specified under par. (f) 35. to 47. An additional fee of \$40

BILL**SECTION 1**

1 \$50 that is in addition to the fee under subd. 2. shall be charged for the issuance or
2 renewal of a plate issued on a biennial basis for a special group specified under par.
3 (f) 35. to 47. if the plate is issued or renewed during the first year of the biennial
4 registration period or ~~\$20~~ \$25 for the issuance or renewal if the plate is issued or
5 renewed during the 2nd year of the biennial registration period. The fee under this
6 subdivision is deductible as a charitable contribution for purposes of the taxes under
7 ch. 71.
