5 providing qualified interpreters to indigent persons with limited English proficiency
6 under this section shall be paid as follows:

7 SECTION 4m. 885.38 (8) (b) of the statutes is amended to read:

8 885.38 (8) (b) The state public defender shall pay the expenses for interpreters
9 assisting the state public defender in representing an indigent a person in preparing
10 for court proceedings."
