Please prepare two more separate amendments to LRB-4750/1:

- 1. That the legislature, in its approval or disapproval of the compact, will be allowed by amendment to *require* that the scope of the compacts be expanded to include specific topics germane to the running of casinos, specifically including but not limited to workers' compensation and collective bargaining issues.
- 2. That JCLO is required to disapprove any proposed compact which does not include the right of all workers in gaming industries to organize into unions, and collectively bargain etc.
