


Hi Rick and Robin -

Please prepare two more separate amendments to LRB-4750/1 :

1. That the legislature, in its approval or disapproval of the compact, will be allowed by amendment to *require* that the scope of the compacts be expanded to include specific topics germane to the running of casinos, specifically including but not limited to workers' compensation and collective bargaining issues.
2. That JCLO is required to disapprove any proposed compact which does not include the right of all workers in gaming industries to organize into unions, and collectively bargain etc.

1 At the locations indicated, amend the bill as follows:

2 1. Page 2, line 6: after "(2)" insert "(a)".

3 2. Page 2, line 10: delete "If" and substitute "Subject to par. (b), if".

4 3. Page 2, line 17: after that line insert:

5 "(b) The joint committee on legislative organization may not approve any
6 proposed compact that does not specifically provide individuals who are employed at
7 a gaming establishment governed by the compact with the right to engage in
8 collective bargaining on issues related to wages, hours, and conditions of
9 employment."
