


# 2003 SENATE JOINT RESOLUTION

1 **Relating to:** congratulating and commending the University of Wisconsin  
2 Milwaukee Men's Basketball Team and Head Coach Bruce Pearl on earning  
3 their first NCAA Division I Tournament appearance.

4 Whereas, ~~Whereas~~ the University of Wisconsin Milwaukee Panthers, under  
5 the direction of Head Coach Bruce Pearl, earned a spot in the NCAA Division I  
6 Tournament for the first time in the 107-year history of the basketball program; and

7 Whereas, the Panthers finished the regular season with a record of 24-7,  
8 claiming a ~~second~~ <sup>2nd</sup> place finish in the Horizon League ~~ending~~ <sup>and</sup> at 13-3 in conference  
9 play, capping their best Division I record in school history; and

10 Whereas, with the leadership, dedication <sup>and</sup> and ambition of a head coach in his  
11 ~~second~~ <sup>2nd</sup> year at the University of Wisconsin Milwaukee, the Panthers' 24 victories  
12 this season tie a school record for wins in a single season; and

13 Whereas, the spectacular victory on their home court over the Butler Bulldogs,  
14 in front of 10,115 fans, the largest home crowd in ~~UMM~~ history, gave the Panthers  
15 a perfect home record of 13-0, including 11-0 at the Klotsche Center; and

1 Whereas, Bruce Pearl was named Horizon League Coach of the Year for the

4 Whereas, Coach Pearl's 40 wins with the Panthers in his first ~~two~~ <sup>2</sup> seasons ties  
5 a school record for the most wins in a coach's first ~~two~~ <sup>2</sup> years at the University of

7 Whereas, the fans of the University of Wisconsin-Milwaukee Panthers will  
8 break out their black and gold apparel and gather together to cheer on the team as  
9 they enter the "Big Dance"; now, therefore, be it
