This joint resolution provides that debate in either house of the legislature may not be limited except by a vote of two-thirds of the members present.

Resolved by the senate, the assembly concurring, That:

SECTION 1. Joint rule 83 (1) is amended to read:

JOINT RULE 83 (1) During any scheduled floorperiod the introduction, or offering, and disposition of proposals and the offering and disposition of amendments, and of certificates under joint rule 7, shall in each house be governed by the rules thereof, except that debate in either house may not be limited except by a vote of two-thirds of the members present.
