

3 1983, in Neenah, Wisconsin, and died on Sunday, October 26, 2003, in Abu Ghraib,
4 Iraq, during a mortar attack on an Iraqi police station; and

5 Whereas, PFC Bosveld served with distinction with the 527th Military Police
6 Company based in Giessen, Germany; and

7 Whereas, PFC Bosveld graduated from Waupun High School in 2003 after
8 transferring from Oshkosh West High School; and

9 Whereas, PFC Bosveld enjoyed art activities, loved to play the violin, and
10 participated in numerous school plays including playing Frieda in Waupun High
11 School's "You're a Good Man, Charlie Brown"; and

12 Whereas, PFC Bosveld chose to follow the family tradition of serving her
13 country in the military; and

14 Whereas, PFC Bosveld made the ultimate sacrifice for her country while
15 advancing the cause of freedom for the Iraqi people; and

1 Whereas, PFC Bosveld will always be remembered for her loyalty and duty and
2 will never be forgotten; now, therefore, be it
