16 **SECTION 1.** Senate rule 1 (title) and (1) are amended to read:

17 SENATE RULE 1 (title) **President; president pro tempore.** (1) The senate
18 shall ~~designate elect, by roll call vote,~~ one of its members to serve as president for the
19 ~~legislative biennium and one to serve as president pro tempore.~~ The president and
20 president pro tempore shall serve for the biennial session unless separated by death,
21 resignation, or removal by the adoption of a resolution by a majority of the current
22 membership.

1 **SECTION 2.** Senate rule 1m (2) is amended to read:

2 SENATE RULE 1m (2) Every officer of the senate is subordinate to the committee
3 on senate organization and, in all that relates to the discharge of that officer's ~~several~~
4 duties, is under the supervision of the committee on senate organization.

5 **SECTION 3.** Senate rule 2 is amended to read:

6 SENATE RULE 2. **Substitute president.** (1) When the president is absent or
7 unable to preside over the senate sitting in session, the president pro tempore may
8 preside and assume all of the duties enumerated under rule 4. The substitution ~~shall~~
9 does not extend beyond adjournment and ~~shall end~~ ends upon the president's return
10 or the election of a new president.

11 (2) When the president and president pro tempore are absent or unable to
12 preside, the senate shall elect, by roll call vote, one of the its members shall be elected
13 to temporarily perform all of the duties enumerated under rule 4 until the president
14 or president pro tempore returns and is able to preside.

15 (3) The presiding officer may call any member to the chair, but the substitution
16 ~~shall~~ does not extend beyond an adjournment or the return of the president.

17 **SECTION 4.** Senate rule 3 is amended to read:

18 SENATE RULE 3. **Duties of president pro tempore and majority leader.**
19 When the president is separated by death, resignation, or removal from office, or is
20 otherwise unable to serve, all of the powers and duties of the president not
21 enumerated in rule 4 shall devolve upon the president pro tempore until a president
22 is elected. When both the president and president pro tempore are separated by
23 death, resignation, or removal from office, or are otherwise unable to serve, all of the
24 powers and duties of the president not enumerated under rule 4 shall devolve upon
25 the majority leader until a president is elected.

1 **SECTION 5.** Senate rule 3m is amended to read:

2 SENATE RULE 3m. **Voting by presiding officer.** A senator may not be excused
3 from voting on ~~any a~~ question by reason of occupying the chair.

10 the chair and calling the members to order.

11 (g) Inform the senate when necessary, or when referred to for that purpose, on
12 any point of order or practice procedure.

13 **SECTION 7.** Senate rule 4 (10) is renumbered senate rule 4 (2) and amended to
14 read:

15 SENATE RULE 4 (2) Refer The president shall refer every notice and report
16 concerning a proposed administrative rule received by ~~him or her~~ the presiding
17 officer under section 227.19 of the statutes to the appropriate standing committee of
18 the senate within 7 working days following receipt, and provide notice to that
19 committee whenever the president is informed that a proposed rule is being
20 withdrawn. The president shall refer any report received from a standing committee
21 that objects to a proposed rule to the joint committee for review of administrative
22 rules.

23 **SECTION 8.** Senate rule 5 (1), (2) (c), (3) and (4) are amended to read:

24 SENATE RULE 5 (1) The At the commencement of each biennial session, the
25 senate shall elect, by roll call vote, a chief clerk of the senate shall be elected at the

1 ~~commencement of each regular session, to.~~ The chief clerk shall hold office for the
2 full 2-year term of the legislature and until a successor is elected and qualified on
3 the day of convening of the next legislature as established under section 13.02 (1) of
4 the statutes unless ~~removed~~ separated by death, resignation, or ~~the vote of removal~~
5 by the vote of a majority of the actual present membership of the senate.

6 (2) (c) Prepare and transmit for reproduction its daily journal after the ~~close~~
7 adjournment of each daily session, and, if so directed by the president or chairperson
8 of the committee on senate organization, on any day on which the senate does not
9 meet.

10 (3) The chief clerk ~~shall be~~ is responsible for all official acts of the employees
11 assigned to that office, and may designate one of those employees as assistant chief
12 clerk, who ~~shall have~~ has general supervision under the direction of the chief clerk
13 and in the temporary absence of the chief clerk ~~shall have~~ has all of the powers and
14 duties of the chief clerk. If the chief clerk is separated by death, resignation, or
15 removal from office, the assistant chief clerk may exercise all of the powers and shall
16 carry out all of the duties of the chief clerk until a chief clerk is elected.

17 (4) On the day of convening of the next legislature as established under section
18 13.02 (1) of the statutes, when the president, president pro tempore, majority leader,
19 and assistant majority leader are absent or unable to preside over the senate sitting
20 in session and the senate does not elect a substitute president under rule 2 (2), the
21 chief clerk shall perform all of the duties enumerated under rule 4.

22 **SECTION 9.** Senate rule 6 (1) and (2) (b) and (f) are amended to read:

23 SENATE RULE 6 (1) The At the commencement of each biennial session, the
24 senate shall elect, by roll call vote, a sergeant at arms of the senate shall be elected
25 at the commencement of each regular session, to. The sergeant at arms shall hold

1 office for the full 2-year term of the legislature and until a successor is elected and
2 qualified on the day of convening of the next legislature as established under section
3 13.02 (1) of the statutes unless ~~removed~~ separated by death, resignation, or ~~the vote~~
4 of removal by the vote of a majority of the actual present membership of the senate.

5 (2) (b) Perform all the duties that may be assigned to the sergeant connected
6 with the maintenance of decorum and good order in the chamber ~~and in the galleries.~~

7 (f) Ensure that the chamber is properly ventilated and is open for the use of the
8 members as directed by the presiding officer or from one hour preceding any each
9 daily session until one hour after that day's adjournment.

10 **SECTION 10.** Senate rule 7 (1) to (4) are amended to read:

11 SENATE RULE 7 (1) The presiding officer shall preserve order and decorum; ~~;~~ may
12 speak to points of order in preference to others, rising for that purpose; and shall
13 decide questions of order, subject to an appeal by a member, on which appeal each
14 member may speak once not to exceed 5 minutes.

15 (2) Whenever a point of order is raised, the presiding officer may rule thereon
16 forthwith, or may defer the decision not later than the 5th order of business on the
17 2nd legislative day thereafter to provide time for examination of the precedents.
18 Questions not ruled on within the required time shall be decided by a majority of the
19 senate.

20 (3) Whenever the presiding officer ~~finds it necessary to take~~ takes a point of
21 order under advisement in order to consult sources of parliamentary law and
22 ~~practice~~ procedure, the presiding officer shall submit the decision in writing, stating
23 the source consulted and the reasons for the decision. The text of the presiding
24 officer's decision shall be ~~spread~~ recorded in upon the journal.

1 (4) On appeal being taken, the question ~~shall be~~ is “Shall the decision of the
2 presiding officer stand as the judgment of the senate?”, which question, and the
3 action thereon, shall be entered on the journal. The vote is taken by ayes and noes.
4 A tie vote sustains the ruling of the presiding officer.

5 **SECTION 11.** Senate rule 8 (title), (1), (4) and (5) are amended to read:

6 SENATE RULE 8 (title) **Conduct during floor while sitting in session.** (1)
7 Members, officers, and employees shall wear appropriate attire while the senate is
8 sitting in session. Appropriate attire for men includes the wearing of a coat.

9 (4) A member or other person may not, within the bar of the senate, read
10 newspapers or consume food, beverages, or ~~any~~ tobacco products.

11 (5) A member or other person may not smoke within the ~~bar of the senate, the~~
12 ~~staff and press lobbies, and the visitors’ galleries~~ chamber.

13 **SECTION 12.** Senate rule 11 (2), (3) and (5) are amended to read:

14 SENATE RULE 11 (2) Persons of the following classes, and no others, shall be
15 admitted to that portion of the floor of the senate designated as the staff lobby ~~during~~
16 while the senate is sitting in session thereof: state officers, employees of either house
17 of the legislature, of legislative committees, and of legislative service agencies while
18 engaged in the performance of their duties, members of congress, justices of the
19 supreme court, and former members of the legislature.

20 (3) However, none of those persons in subs. (1) and (2) who are registered as
21 lobbyists or engaged in defeating or promoting any pending legislation have the
22 privilege of the area floor of the senate.

23 (5) All accredited correspondents of the news media, who confine themselves
24 to their professional duties, have the privilege of the floor of the senate, except that

1 ~~during the sessions of the senate~~ while the senate is sitting in session the privilege
2 extends only to the press lobby.

3 **SECTION 13.** Senate rule 12 is amended to read:

4 SENATE RULE 12. **Privileges of senate to contestants for seats.** Contestants
5 for seats have the privilege of the senate until their respective cases are disposed of;
6 ~~the.~~ The privilege to extend extends only so far as access to the chamber, during the
7 time occupied in settling the contest.

8 **SECTION 14.** Senate rule 13 is amended to read:

9 SENATE RULE 13. **Disturbance in lobby.** Whenever any disturbance or
10 disorderly conduct occurs on the senate floor or in the lobby or gallery, the presiding

23 (c) Third order. Introduction, first reading, and reference of ~~bills~~ proposals.

24 **SECTION 17.** Senate rule 18 (1) is amended to read:

1 SENATE RULE 18. (1) All proposals, appointments, or other business, referred
2 to a committee and reported by it to the senate or withdrawn from it by the senate,
3 all proposals or amendments received from the assembly for senate concurrence, and
4 all reports from conference committees and veto messages received by the senate,
5 shall be placed in the committee on senate organization. Any such business
6 deposited with the chief clerk on a day when the senate does not meet may be placed
7 in the committee on senate organization immediately, but shall be formally received
8 by the senate on its next meeting day. The committee on senate organization shall
9 establish a calendar, grouping together proposals, appointments, or other business
10 according to similar subjects and in an appropriate order, and in such numbers as
11 to constitute a workable and up-to-date calendar schedule. The committee on
12 senate organization shall place a proposal, appointment, or other business on the
13 calendar when directed to do so by a majority vote of the senate. ~~The chairperson of~~
14 ~~the committee on senate organization may place a proposal, appointment, or other~~
15 ~~business that is in the committee on senate organization on a calendar that has been~~
16 ~~established by the committee.~~

17 **SECTION 18.** Senate rule 20 (1) (c), (2) (a) and (7) are amended to read:

18 SENATE RULE 20 (1) (c) The other standing committees of the senate shall be
19 created by the committee on senate organization as near to the commencement of the
20 biennial session as possible.

21 (2) (a) The chairperson of the committee on senate organization, as near to the
22 commencement of the biennial session as possible, shall make and report to the
23 senate all committee appointments of members of the majority and minority parties.
24 The chairperson of the committee on senate organization shall designate a
25 chairperson for each senate committee and joint committee.

1 (7) Whenever ~~any~~ a member of the committee on senate organization is
2 disabled and unable to serve, the senate may select a temporary replacement from
3 among those senators of the same party affiliation. The replacement terminates
4 upon the return of the disabled member.

11 by the committee on senate organization, designating the number and object, and be

14 **SECTION 21.** Senate rule 22 (2) is amended to read:

15 SENATE RULE 22 (2) On the question of the confirmation of appointments by the
16 governor or the state superintendent of public instruction, the vote shall be taken by
17 ayes and noes, which shall be entered upon the journal. The question of confirmation
18 of the appointments is not subject to a motion for reconsideration under rule 67. The
19 senate may, but is not required to, act upon an appointment resubmitted by the
20 governor or the state superintendent of public instruction when the identical
21 appointment has once been refused confirmation by the senate. The chief clerk shall
22 record the cumulative status of all appointments in the bulletin of proceedings. The
23 senate shall inform the governor and the assembly of the senate's final action on
24 confirmation of a nomination for appointment that requires assembly confirmation.

15 of the same biennial session may be introduced or offered.

18 ~~procedures~~ proceedings are declared not to be within the meaning of the term
19 "business" under the constitutional provision limiting the matters to be considered
20 during special sessions to those enumerated in the governor's call for a special
21 session.

4 [see also sub. (50m)].

5 (39) JOINT RESOLUTION: A proposal requiring adoption by both houses, to: a)
6 express the opinion of the legislature; b) change the joint rules of the legislature; c)
7 propose an amendment to the state constitution; or d) propose or ratify an
8 amendment to the U.S. constitution.

9 (40) JOINT RULES: The common rules of ~~procedure~~ proceedings adopted by both
10 houses.

11 (44) MAIN MOTIONS AND QUESTIONS: The final affirmative question concerning
12 a proposal during any stage of its consideration or any a motion made or question
13 raised when no other matter is before the house. Main questions have lower
14 precedence than privileged, incidental, and subsidiary questions.

15 (48) MEMBERS PRESENT: Those members in attendance at a daily session
16 meeting of the senate.

17 (50) NONCONCURRENCE: The refusal of one house to agree to a proposal,
18 amendment, or action of the other.

19 (50m) OFFER: The formal presentation of a joint resolution, resolution,
20 substitute amendment, amendment, or motion before a house [see also sub. (36)].

21 (52) PAIR: A written agreement between 2 members on opposite sides of a
22 question not to vote on that question while one or both are absent with leave, ~~thereby~~
23 permitting which permits the absent member to influence the outcome of a vote.

24 (53) PARLIAMENTARY INQUIRY: A request for an explanation of a legislative rule
25 or procedure proceeding.

1 (54) **PASSAGE:** Final approval in the first house of a bill introduced in that house
2 if referring to action of one house and final approval of both houses of a bill introduced
3 in either house if referring to action of both houses [see also subs. (3) and (16)].

4 (57m) **PRESIDENT PRO TEMPORE:** A member of the senate, elected by the
5 membership to carry out the duties of the president in his or her absence until the
6 return of the president or until a president is elected.

7 (59) **PRIVILEGED MOTIONS AND REQUESTS:** A group of motions and requests
8 relating to basic questions concerning the meetings, organization, rules, rights, and
