1 **Relating to:** supporting the reauthorization of the existing Community Services
2 Block Grant and its funding to community action agencies.

3 Whereas, Wisconsin's 16 ~~Community Action Agencies~~ have been working in our
4 communities to improve the lives and well-being of all of our citizens for over 35 years;
5 and

6 Whereas, our community action agencies have delivered a comprehensive
7 array of opportunities to assist those citizens who reside at the lowest levels of the
8 economic ladder, to advance economically and socially; and

9 Whereas, our community action agencies have developed innovative and
10 effective strategies to promote affordable housing and homeownership,
11 micro~~enter~~prise development, youth development, crime prevention, access to food
12 and nutrition, Head Start expansion, community~~y~~-based economic development,
13 housing rehabilitation, and other initiatives to promote the development of our
14 human potential; and

1 Whereas, our community action agencies in ~~the year~~ 2001 assisted over 380,000
 2 of our citizens and provided volunteers who contributed more than 600,000 hours of
 3 service to our communities; and

4 Whereas, our 16 community action agencies in 2001 received \$7,000,000 of
 5 Community Service Block Grant funds and used these funds to leverage more than
 6 \$135^{,000,000} million of additional funds, including \$²⁵ million of private funds with which
 7 to benefit Wisconsin's communities; and \$25,000,000

8 Whereas, the federal Community Services Block Grant provides the core
 9 funding for our community action agencies and is scheduled for reauthorization in
 10 the upcoming session of Congress; now, therefore, be it

11 **Resolved by the senate, That** the Wisconsin ~~State~~ ~~Senate~~ urges President
 12 George W. Bush and the Wisconsin congressional delegation to support the
 13 reauthorization of the existing Community Services Block Grant and its funding to
 14 community action agencies; and, be it further

15 **Resolved, That** the senate chief clerk shall provide a copy of this resolution to
 16 President George W. Bush, to the president and secretary of the U.S. senate, to the
 17 speaker and clerk of the U.S. house of representatives, and to each member of the
 18 congressional delegation from this state, attesting the adoption of this ~~(joint)~~
 19 resolution by the 2003 senate of the state of Wisconsin.
