2003 SENATE RESOLUTION



To renumber senate rule 14 and senate rule 91; to repeal and recreate senate rule

14 (title); and to create senate rule 14 (2) and senate rule 91 (2); relating to:

the ending time of the daily sessions of the senate.

Analysis by the Legislative Reference Bureau

This resolution provides that the senate sessions will end no later than midnight. However, the resolution permits a majority of the members to suspend the rule to complete the consideration of the proposal that is being considered at midnight. Otherwise, the senate is prohibited from being in session between midnight and 7 a.m.
