


Whereas, the Central Intelligence Agency and the United States Armed Forces recruited, organized, trained, and assisted Hmong guerrilla united and conventional forces from 1960 through 1975 to combat the North Vietnamese Army and Communist Pathet Lao forces; and

Whereas, the United States is now the home to significant community of the Hmong veterans and their families after providing them with political asylum, refugee status, and citizenship because of their unique contribution to the United States national security interests during the Vietnam War; and

Whereas, the Wisconsin Lao Veterans of American has established chapters throughout the state that have sought to serve their community and educated the public about the historic contribution of the Hmong veterans during the Vietnam War: and

Whereas, due to a death of a Wisconsin Lao Veterans of American member, the organization will be performing their own Proper Burial that include the Casket Team, Escorting Team, Rifle Team, Color Guard Team, Band and a bugler and;
