1 At the locations indicated, amend the resolution as follows:

2 1. Page 2, line 13: after that line insert:

3 "Whereas, as part of Medicare legislation being developed in Congress, the U.S.
4 house of representatives passed the Pharmaceutical Market Access Act, which
5 requires the federal food and drug administration, within 180 days of enactment, to
6 design and implement a system to grant individuals, pharmacists, and wholesalers
7 in America the ability to import FDA-approved drugs from FDA-approved
8 manufacturing facilities in 26 industrialized nations; and

9 Whereas, this provision would also require imported medicine to be shipped in
10 antitampering and anticounterfeiting packaging; and".
