5 docks.

The department of administration shall carry out any such contractual obligations until modified or rescinded by the department of administration to the extent allowed under the contract.

(d) *Employee transfers and status.* Between May 1, 2001, and October 1, 2001, all incumbent employees holding positions in the office of the state treasurer who perform cash management functions, other than functions under chapter 177 of the statutes, are transferred to the department of administration. The secretary shall determine the date on which each such employee is transferred.
