This is a budget drafting request to eliminate DER and re-locate its existing functions into a new division of DOA, headed by an unclassified administrator appointed by the Secretary of Administration (the only unclassified position to be retained). Except for the administrator retained for the division, the other existing unclassified administrators in DER should be eliminated, along with the secretary, deputy secretary and executive assistant. All Chapter 230 authorities and corolary Chapter 111 provisions should be realigned appropriatedly to coincide with DOA.

Undoubtably, there will be numerous questions from the drafter(s). Since this is not a final decision, we welcome any and all issues LRB staff may identify as this policy matter is considered here.
