Title: Hospital and Nursing Home Fee Revenue Allocation

Current Language

S. 20.435(4)(gm). *Health services regulation and vital statistics*...From the fees collected under s. 50.135(2), \$310,100 in fiscal year 2001-2002 and \$309,300 in fiscal year 2002-2003 shall be credited to this appropriation account.

Proposed Change

S. 20.435(4)(gm). Health services regulation and vital statistics...From the fees collected under s. 50.135(2), \$310,100 \$334,800 in fiscal year 2001-2002 2003-2004 and \$309,300 \$338,200 in fiscal year 2002-2003 2004-2005 shall be credited to this appropriation account.

Background and Rationale for the Change

Revenues from licensing and approval fees paid by nursing homes and hospitals under s. 50.135 are divided between the appropriations under s. 20.435(4)(gm) and (6)(jm). Under current law, \$310,100 in FY 02 and \$309,300 in FY 03 are allocated to (4)(gm), with the remainder allocated to (6)(jm). The proposed change increases the (4)(gm) allocation based on a reestimate of costs in that appropriation.
