

Request Description:

The Governor proposes to increase, from \$2.00 to \$3.50, the Milwaukee Special Prosecution fee charged by the clerk of the Milwaukee County Court.

The State Prosecutors Office reimburses the Milwaukee County DA office for the clerical wages of 2.00 FTE firearm prosecution clerical staff. By increasing the fee, the PR-S fee source would have sufficient resources to fully fund these two positions.


