Note:

The Governor's bill would increase funding for the appropriation that supports DVA's institutional operations by \$105,000 PR annually to support the proposed nurse stipend program. This appropriation is supported by a combination of revenue from members in DVA's care facilities, per diem payments DVA receives from the U.S. Department of Veterans Affairs, and medical assistance (MA) payments budgeted in the Department of Health and Family Services.

This motion would delete the GPR MA benefits funding budgeted to support the nurse stipend program, and instead fund the state's share of these costs with unallocated revenue from the segregated veterans trust fund.
