Modify statutory language to specify that in proceedings and in proceedings under Chapter 48 (Children's Code), 51 (Mental Health Code) (protective service proceeding), or 938 (juvenile proceeding), if the court determines that the person has limited English proficiency and that an interpreter is necessary, the court must advise the person that he or she has the right to a qualified interpreter at the public's expense.
