Reduce GPR Grant Appropriations with a 10% Lapse Requirement

Motion:

Move to require a 10% lapse of funding from the following programs annually in the 2003-05 biennium: (a) state aid for the arts (\$119,700 GPR-Lapse annually); (b) the challenge grant program (\$77,900 GPR-Lapse annually); and (c) the Wisconsin regranting program (\$12,400 GPR-Lapse annually).

Note:

This motion would impose a 10% lapse requirement on the three GPR funded grant programs under the Arts Board. These programs include:

20.215 (a) (b) a. *State Aid for the Arts.* The state aid for the arts program supports a variety of contracts with or grants to groups, individuals, and organizations concerned with or involved in artistic activities. Grant recipients are required to provide at least 50% of the estimated total project cost. Funding for the state aid for the arts program under SB 44 would be \$1,432,700 (\$1,196,700 GPR and \$236,000 FED) annually.

20.215 (1)(d) b. *Arts Challenge Initiative.* Grants are awarded to nonprofit arts organizations to encourage local fund-raising efforts. The grants are awarded in the following categories: (a) incentive, which awards grants to arts organizations with annual operating budgets of at least \$100,000, whose fund-raising income exceeds that of the previous year; (b) sustaining, which awards grants to arts organizations with annual operating budgets less than \$100,000, whose fund-raising income exceeds that of the previous year; and (c) minority, which awards grants to arts organizations with substantial control by members of a minority group whose fund-raising income meets or exceeds that of the previous year. Funding for the arts challenge initiative program under SB 44 would be \$778,800 GPR annually.

26.215 (1)(f) c. *Wisconsin Regranting Program.* Grants are awarded to local arts agencies and municipalities, which are required to provide a public or private match equal to the amount of the grant. The agency or municipality, in turn, regrants the funds to arts organizations and artists in the community, which are required to use the grants, at least in part, for a public service activity, such as a concert or exhibition, that is open to the entire community. Funding for the Wisconsin regranting program under SB 44 would be \$124,300 GPR annually.
