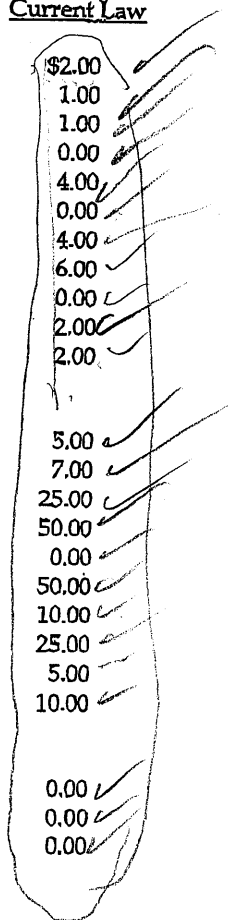
Hunting and Fishing License Fees
[Paper #530 and Paper #531]

Motion:

Move to adopt Alternative 5 from paper #530, deleting the provision. Instead, provide for the hunting and fishing fee modifications shown in the following table. In addition, adopt Alternative 2a from paper #531, which would provide the amount of funding recommended by the Governor under the bill for CWD management, but would provide funding from wildlife damage surcharge revenues rather than from the available balance of the fish and wildlife account. Finally, delete \$1,500,000 SEG annually in fish and wildlife account expenditures related to the Department's Administration and Technology general operations [s. 20.370 (8)(mu)].

Note:

The motion would reduce revenues to the fish and wildlife account, compared to the bill, by \$2,406,800 in 2003-04 and by \$9,267,300 in 2004-05 and reduce general fish and wildlife account expenditures by \$3,094,700 in 2003-04 and \$2,965,800 in 2004-05 (\$3,060,500 in expenditures would be shifted to wildlife damage revenues for CWD management). Under the motion, the fish and wildlife account would be expected to have a June 30, 2005, balance of approximately \$190,000.
