

Analysis by the Legislative Reference Bureau

Currently, a person who hunts deer, elk, or bear must wear a back tag issued by the Department of Natural Resources, in addition to obtaining a hunting license and a deer, elk, or bear tag. This bill eliminates the requirement that a hunter wear a back tag.
