CURRENT LAW

The Department of Corrections has a state operations base budget (less fuel and utilities, and debt service) of \$620,535,200 GPR and 8,784.06 GPR positions, \$141,124,100 PR and 1,430.10 PR positions, and \$2,589,900 FED and 3.0 FED positions.

GOVERNOR

Delete \$11,549,900 and 196.98 annually (-\$9,666,000 GPR and -164.98 GPR positions annually, -\$77,700 FED and -2.0 FED positions annually, -\$1,806,200 PR and -30.0 PR positions annually) in Corrections' state operations appropriations.

DISCUSSION POINTS

1. Under the bill, reductions are made to the Department of Corrections as identified in Table 1.

- 2. According to the Executive Budget Book, the budget reductions are intended to "create additional operational efficiencies and balance the budget by: (a) eliminating the Division of Correctional Programs by eliminating some units and transferring remaining units into the Divisions of Adult Institutions and Community Corrections; and (b) streamlining management and oversight of central office functions by eliminating many middle management positions and also certain specialized support functions."
- 3. The reductions under the bill represent a 1.6% reduction to the Department's GPR state operations budget, less debt service, and fuel and utilities; 1.3% of PR state operations; and 3.0% of FED state operations.
- 4. On March 17, 2003, DOA indicated that: "Further review of the specific positions being eliminated has identified a lower level of savings than initially estimated. Operating funding needs to be increased by \$257,000 GPR in FY 04 and FY 05 to more accurately reflect savings from these reductions." Funding and position reductions in SB 44 represent target amounts for Corrections. Subsequent to introduction of the bill, DOA and Corrections determined reductions based on specific positions.
- 5. Table 2 identifies the annual reductions contained in Senate Bill 44, the changes recommended by DOA, and the difference in funding and positions by division and unit. Of the positions eliminated, 63.38 positions are vacant (54.88 GPR and 8.5 PR).

- 6. As identified in Table 2, the modifications recommended by DOA would result in an annual funding increase to SB 44 of \$344,200 (\$257,000 GPR and 0.5 GPR position and \$87,200 PR and -0.5 PR position). In order to retain the overall GPR reduction in Corrections' budget, the modification could be adopted but the Department's largest GPR state operations appropriation (general program operations) reduced by a corresponding \$257,000 GPR annually. Under this alternative, the total reduction to Corrections would be \$11,462,700 and 196.98 positions annually (\$9,666,000 GPR and 164.48 GPR positions, \$1,719,000 PR and 30.50 PR positions, and \$77,700 FED and 2.0 FED positions).
- 7. Under s. 230.08(2)(e)3e. of the statutes, the Department of Corrections is authorized five unclassified division administrator positions. In SB 44, funding and position authority associated with the administrator for the Division of Correctional Programs position are eliminated. However, the statutory designation for division administrators is not modified. Given that the Governor indicates that Division of Correctional Programs will be eliminated as a result of SB 44, it can be argued that the number of authorized division administrator positions should be reduced to four. In addition, it should be specified that 1.0 GPR of the 164.48 GPR positions eliminated is an
