SENATE SUBSTITUTE AMENDMENT ,  
TO 2003 SENATE BILL 44

1 AN ACT relating to: state finances and appropriations, constituting the  
2 executive budget act of the 2003 legislature.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

3 SECTION 4. 7.33 (4) and (5) of the statutes are amended to read:

4 7.33 (4) Except as otherwise provided in this subsection, each local  
5 governmental unit, as defined in s. ~~22.01~~ 16.97 (7), may, and each state agency shall,  
6 upon proper application under sub. (3), permit each of its employees to serve as an  
7 election official without loss of fringe benefits or seniority privileges earned for  
8 scheduled working hours during the period specified in sub. (3), without loss of pay  
9 for scheduled working hours during the period specified in sub. (3) except as provided  
10 in sub. (5), and without any other penalty. For employees who are included in a  
11 collective bargaining unit for which a representative is recognized or certified under

1 subch. V of ch. 111, this subsection shall apply unless otherwise provided in a  
2 collective bargaining agreement.

3 (5) Any employee of a local governmental unit, as defined in s. ~~22.01~~ 16.97 (7),  
4 or state agency who obtains a paid leave of absence under sub. (4) in order to serve  
5 as an election official under s. 7.30 shall certify in writing to the head of the local  
6 governmental unit or state agency by which he or she is employed the amount of  
7 compensation that the employee receives for such service. Upon receipt of the  
8 certification, the head of the local governmental unit or state agency shall deduct  
9 that amount from the employee's pay earned for scheduled working hours during the  
10 period specified in sub. (2) when the employee is on a paid leave of absence.

21 any information from other state agencies, local governments or individuals or  
22 organizations that is reasonably necessary for the department to prepare the report.

14 manner, but because of the uncertainties of the existing situation no public funds  
15 should be expended or obligations incurred unless there shall be adequate revenues  
16 to meet the expenditures therefor. For such reason the committee may make  
17 reductions of such appropriations as in its judgment will secure sound financial  
18 operations of the administration for said state agencies and at the same time  
19 interfere least with their services and activities.

24 including any Saturday or Sunday unless the legislator is in actual attendance on

1 the legislator is a member. The amount of the allowance for each biennial session  
2 shall be 90% of the per diem rate for travel for federal government business within  
3 the city of Madison, as established by the federal general services administration.  
4 For the purpose of determining the amount of the allowance, the ~~secretary of~~  
5 ~~employment relations~~ director of the office of state human resources management  
6 shall certify to the chief clerk of each house the federal per diem rate in effect on

10 allowance the member wishes to receive. Such affidavit, when filed, shall remain in

15 (5).

18 be paid in accordance with the compensation and classification plan for employees  
19 in the classified civil service within ranges approved by the joint committee on

21 of state human resources management shall make recommendations concerning a  
22 compensation and classification schedule for legislative employees if requested to do
