The joint finance motion that reduced stewardship bonding authority also contained the following:

1. Specific earmark language for Peshtigo State Forest
2. A provision lowering the monetary threshold for JCF oversight of stewardship projects from \$250,000 to \$0.
3. A provision giving JCF oversight on DNR allowing exemption for certain best management practices in forested areas.
4. Changes the timing deadlines in s. 23.0917 (5m) (b) 3. and 4.
