Require the Secretary of Health and Family Services to establish a task force to address the shortage of dental services available to BadgerCare and MA patients in Marathon, Oconto, Forest, Oneida, Vilas and Florence Counties.

The task force would be headed by Ann Hogan of the Executive Director of the Northern Health Center in Lakewood, WI. Member of the task force would include hospital administrators from the above counties and dental providers.

The task force would write a proposal on ways to recruit more dentists to these areas, ways to get more dentists to accept BadgerCare and MA patients and new facilities or equipment needed to increase services provided.

Give \$15,000 to North Central Technical College Health Center.

The money will be spent on dental equipment for the new Health Center. The Health Center would provide most of its services to Badger Care and Medical Assistance patients.

(?) COMMITTEE ON DENTAL SERVICES FOR MEDICAL ASSISTANCE AND BADGER CARE RECIPIENTS. The secretary of health and family services shall, under section 15.04 (1) (c) of the statutes, appoint a committee to address the shortage of dental services available to recipients of Medical Assistance and Badger Care in Marathon, Oconto, Forest, Oneida, Vilas, and Florence Counties. The committee shall include administrators of hospitals and providers of dental care that are located in Marathon, Oconto, Forest, Oneida, Vilas, and Florence Counties, and the chairperson shall be the executive director of the Northern Health Center in Lakewood. By April 1, 2004, the committee shall report to the secretary on incentives for dentists to accept recipients of Medical Assistance and Badger Care as patients

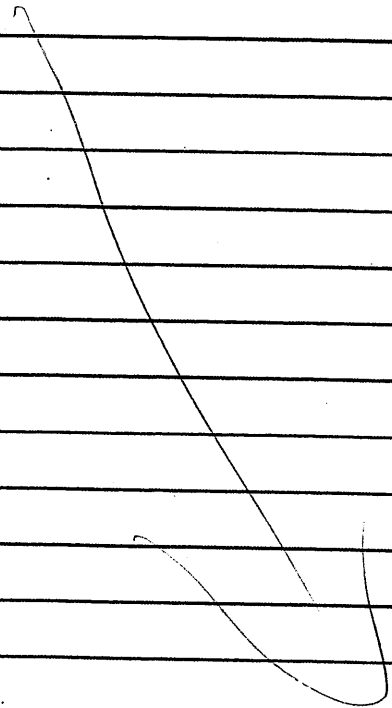
