

TO 2003 SENATE BILL 44**

*Last piece to plug*

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 11, line 5: after that line insert:

3 **"SECTION 20b.** 13.39 of the statutes is created to read:

4 **13.39 Payment by legislature of legal fees.** The senate, assembly, or

5 legislature, or a committee of the senate, assembly, or legislature, may not pay or <sup>reimburse or</sup> <sub>^</sub>

6 authorize the payment or reimbursement of legal fees for a legislator, former

7 legislator, legislative employee, or former legislative employee or for the senate,

8 assembly, or legislature, or a committee of the senate, assembly, or legislature, unless

9 the senate and assembly adopt and concur in, by a vote of two-thirds of the members

10 present and voting in each house, a joint resolution authorizing a single payment or

1 reimbursement of legal fees for that one legislator<sup>or</sup> legislative employee<sup>or for the</sup> legislature,  
2 house, or committee.”
