2003 SENATE JOINT RESOLUTION

1 ***To renumber and amend*** joint rule 85; and ***to create*** joint rule 85 (2); **relating to:**
2 prohibiting the payment of legislative per diems and mileage allowances after
3 June 30 of odd-numbered years that the budget bill or bills have not been
4 messedaged to the governor.

Analysis by the Legislative Reference Bureau

This joint resolution amends the joint rules to prohibit the payment of legislative per diems and mileage allowances after June 30 of odd-numbered years that the executive budget bill or bills have not been messaged to the governor.

5 ***Resolved by the senate, the assembly concurring, That:***

6 **SECTION 1.** Joint rule 85 is renumbered joint rule 85 (1) and amended to read:

7 JOINT RULE 85 (1) ~~For~~ Except as otherwise provided in sub. (2), for any day on
8 which a member of the legislature is in Madison on legislative business pursuant to
9 section 13.123 (1) of the statutes or attends a legislative committee meeting in
10 Madison, the member shall be reimbursed the per diem provided in section 13.123
11 (1) (a) of the statutes. Any legislator who attends a committee meeting outside

1 Madison authorized under joint rule 84 (1) shall be reimbursed for the actual and
2 necessary expenses incurred in attending the committee meeting as provided by
3 section 13.123 (3) of the statutes, or for the round-trip cost of traveling to the meeting
4 from Madison.

5 **SECTION 2.** Joint rule 85 (2) is created to read:

6 **JOINT RULE 85 (2)** The officers of the senate and assembly may not pay or
7 reimburse or authorize the payment or reimbursement for members of per diems for
8 attendance of members in Madison or mileage allowances for travel to Madison,
9 under section 13.08 or 13.123 of the statutes or otherwise, for any day after June 30
10 of odd-numbered years that the executive budget bill or bills introduced under
11 section 16.47 of the statutes have not been messaged to the governor.

1 At the locations indicated, amend the substitute amendment as follows:

2 1. Page 4, line 12: after that line insert:

3 "SECTION 4m. 13.08 (5) of the statutes is created to read:

4 13.08 (5) No allowance shall be paid under this section for any day after June

5 30 of odd-numbered years that the executive budget bills or bills introduced under

6 section 16.47 of the statutes have not been messaged to the governor."

7 2. Page 8, line 14: after that line insert:

8 "SECTION 13m. 13.123 (1) (b) of the statutes is amended to read:

9 13.123 (1) (b) No allowance shall be paid under this subsection for any day

10 during a recess of the legislature for 30 days or more unless so provided by joint

11 resolution adopted by both houses of the legislature. No allowance shall be paid

12 under this subsection for any day after June 30 of odd-numbered years that the

1 executive budget bills or bills introduced under ~~section~~ ^{with} 16.47 of the statutes have not
2 been messaged to the governor."
