I would like to have the following amendment drafted regarding the budget bill passed by the JFC. The topic of the amendment is legislative reform, so I believe this is an issue for you. If someone else needs to prepare this, let me know. There are nine issues to be collapsed into one "legislative reform" amendment. Please give me a call if you have any questions.

**Legislative Reform Amendment.**

- MES* a. Alternative minimum state income tax for legislators of \$1000
- JTK* b. Banning fundraising by members of JFC and majority and minority leaders prior to passage of the budget
- PJD* c. Reduce size of legislature to 66 reps and 22 Senators, effective 2004 election.
- PJD* d. Bar legislators' state-paid out-of-state travel for next two years
- PJD* e. Require both Senate and Assembly to approve the use of public funds to pay for attorney's fees
- PJD* f. No Per Diems for legislators budget does not pass by June 30, 2003
- JTK* g. Require referendum <sup>by next</sup> February 17, 2004, for the following question: "Do you believe that the legislature has done enough in passing measures regarding campaign finance reform?"
- PJD* h. Call for special session to take up the issue of campaign finance reform on Tuesday, September 23, 2003, at 10:00 a.m.
- RAC* i. Legislature must vote on any legislators' pay increases

## 2003 SENATE JOINT RESOLUTION

1 **To create** joint rule 9; **relating to:** authorization by the legislature of salaries of  
2 constitutional officers and other elected state officials.

---

### *Analysis by the Legislative Reference Bureau*

This joint resolution creates a joint rule prohibiting the legislature or any of its committees from increasing the salary of a constitutional officer or other elected state official unless a majority of the members elected to each house adopt and concur in a joint resolution authorizing the increase.

---

3 **Resolved by the senate, the assembly concurring, That:**

4 **SECTION 1.** Joint rule 9 is created to read:

5 **JOINT RULE 9. Authorization by legislature of salaries of constitutional**  
6 **officers and other elected state officials.** The senate, assembly, or legislature,  
7 or a committee of the senate, assembly, or legislature, may not increase or authorize  
8 the increase of the salary of a constitutional officer or other elected state official  
9 designated under section 20.923 (2) of the statutes, unless the senate and assembly

1 adopt and concur in, by a majority of the members elected to each house, a joint  
2 resolution authorizing the increase.

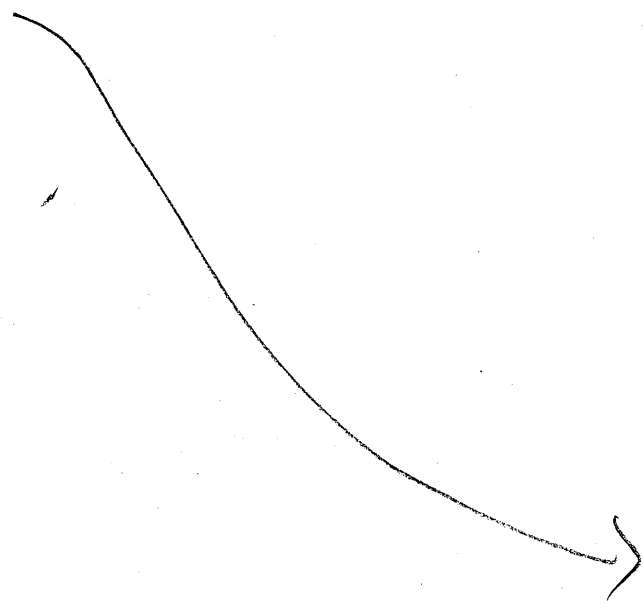

## 2003 BILL

1 **AN ACT to amend 20.923 (2) (b) of the statutes; relating to: setting of legislators'**  
2 **annual salaries.**

---

### *Analysis by the Legislative Reference Bureau*

Currently, annual salaries for state senators and representatives to the assembly are based on the recommendations of the secretary of employment relations, as approved by the Joint Committee on Employment Relations (JCOER). This bill requires JCOER to prepare the approved salary adjustments for state senators and representatives to the assembly in bill form and submit the bill to the legislature for approval and specifies that the salary adjustments may not take effect until the legislature approves the bill.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

3 **SECTION 1.** 20.923 (2) (b) of the statutes is amended to read:

4 20.923 (2) (b) The annual salary of each state senator, representative to the  
5 assembly, justice of the supreme court, court of appeals judge and circuit judge shall  
6 be reviewed and established in the same manner as provided for positions in the  
7 classified service under s. 230.12 (3), except that adjustments of the salaries of each

1 state senator and each representative to the assembly shall in addition be prepared  
2 in bill form by the joint committee on employment relations and submitted as  
3 companion bills to the senate and assembly and shall not take effect until the bill is  
4 enacted on a roll call vote in each house without change. If the bill is not enacted  
5 without change, no adjustment may take effect for each state senator and each  
6 representative to the assembly unless the joint committee on employment relations  
7 submits subsequent companion bills and any such bill is enacted without change.  
8 The bill shall be put immediately on the calendar and shall not be subject to ss.  
9 13.093 (1), 13.50 (6) (a) and (b), and 16.47 (2). The salary established for the chief  
10 justice of the supreme court shall be different than the salaries established for the  
11 associate justices of the supreme court. ✓✓
