Bob,

In order to go back to the Governor's recommendation to delay opening New Lisbon, the following changes would need to be made to the substitute amendment:

- ✓ On page 183, line 3 [(a) General program operations] - reduce 2003-04 funding by \$7,641,400 and 2004-05 funding by \$17,247,500.
- ✓ On page 183, line 7 [(ab) Corrections contracts and agreements] - *increase* 03-04 funding by \$1,022,800 and 04-05 funding by \$16,973,700.
- ✓ On page 184, line 7 [(d) Purchased services for offenders] - reduce 03-04 funding by \$6,300 and 04-05 funding by \$25,000.
- On page 185, line 18 [(km) Prison industries] - reduce 03-04 funding by \$55,900 and 04-05 funding by \$127,500.
