#### Hotline for Reporting Dangerous Weapons in Schools

#### Motion:

Move to delete the statutory requirement that the Department of Justice (DOJ) maintain a toll-free telephone number for persons to provide information anonymously regarding dangerous weapons in schools and delete all statutory provisions governing the administration and operation of this toll-free telephone number by DOJ. Direct DOJ to notify all Wisconsin school districts, via e-mail or otherwise, that the hotline for reporting dangerous weapons in schools will be discontinued. In addition, delete \$50,000 GPR annually provided to DOJ under its Law Enforcement Services general program operations appropriation to operate this toll-free telephone number.

#### Note:

Under 2001 Wisconsin Act 16 (the 2001-03 biennial budget act), DOJ was required to maintain a toll-free telephone number for persons to provide information anonymously regarding dangerous weapons in public schools. DOJ was also provided \$50,000 GPR annually for: (a) purchasing public information and promotion services regarding the hotline; and (b) requiring that after-hours calls to the hotline be answered by a person, not an answering machine.
