8           “SECTION 1272g. 49.175 (1) (zc) of the statutes is created to read:  
9           49.175 (1) (zc) *Southeast Asian recreation programs.* For grants to an  
10          organization that provides summer and after-school recreation programs for  
11          children and families of Southeast Asian origin, \$100,000 in each fiscal year.”.
