1 At the locations indicated, amend the bill as follows:

- 2 ✓ 1. Page 195, line 13: decrease the dollar amount for fiscal year 2003-04 by  
3 \$911,800 and decrease the dollar amount for fiscal year 2004-05 by \$1,013,100 for  
4 the purpose of eliminating the dispensing fee that the department of health and  
5 family services pays pharmacists and pharmacies for repackaging and relabeling  
6 drugs.
