Here are my team's parts for the Boyle amendment:

1. Delete the levy limits inserted by JFC (LRBb0335/3).
2. Go back to the current law distribution formula and funding level for county and municipal aid, but retain the funding sources used by JFC and the deductions for medical assistance payments.
3. Go back to the Governor's distribution levels for county and municipal general transportation aid payments, including the Governor's mileage aid rates.
4. Decrease the transfer under bill section 9253(1) from \$30,000,000 to ~~\$15,641,000~~.
